- An Association Medallion for the Association President and Vice President. Mike is going to Malaysia for the Annual Remembrance at God's Little Batu Gajah in his capacity as the vice President of the NMBVA, he has had a number of invitations to various functions, and the Chairman and Secretary thought only fitting that he should have some Chain of Office, and also at our reunion dinner our President should also have a chain of Office. Ted showed the emblems the Nation Chairman had produced saying once the committee agreed he would get them engraved. Member thought this a good idea and after discussion. It was suggested that names of all vice Chairman go on the medallion, Ted pointed out that this was not practical, Vice was for life and we could have more than one. The following was agreed unanimously that each Vive Chairman would receive one.
- Progress of Plaques at new memorial Ted issued all members with copies of letters appertaining to the project, unfortunately during verbal discussion the Arboretum appeared to be in full agreement, however when the written application was submitted to the Landscape and Memorial committee, they appeared to have changed their policy.

 However I have sent in appeal stating the following:-

The plaques will not be around the memorial, but edging the pathway to the memorial

- 1) They will only add 6 1/2 " to each side of the pathway
- 2) These we believe will enhance the pathway and add interest

We will restrict the number of plaques to a row of one each side of the path
 a. The additional width of 13" will make it easier and safer for wheelchair/mobility scooters.

- Item 15 **Festival Remembrance Royal Albert Hall 2016** (It was proposed that we would mark the 50th Anniversary of the ending of hostilities in Borneo by Parading the NMBVA Standard at the Festival of Remembrance 2016) This in now cancelled see item 6
- Item 16 **Progress St. Paul's David Neil**, this is moving along quite nicely. There is a meeting arranged at St. Paul's at 0930 on the 10th June, and it may be that Sir Garry will join Mal, Ted and myself at this meeting, which will be followed with a meeting at the Mansion House, we see no unsurmountable problems. David, we will have a lot more information by the next meeting, there will not be so many if's and but's so we shall allow more time.

Item 17 Umbrella Organisation, proposed at AGM 2014 Item 10

Setting up an umbrella organisation, to take care and look after the interest of those Veterans who's Associations have folded

The above was a proposal put before the NMBVA, at the AGM 2014 by Mr Ted Pemberton and seconded by Mr M Smith, both of Nottingham Branch. It was agreed the NEC would carry out a feasibility study and report back to members

The NEC carried out this investigation under the directions of Mr David Neil the National Chairman. A thorough investigation, analyse, interview's into all aspects was made. Note this report is only a synopsis of those findings for the NEC perusal

We approached the study from 3 directions

- a) Was there an interest from other Associations, would we get assistance from them, administration cost?
- b) What did the Veterans want? Was it really necessary?
- c) To address specific points made in Ted's presentation

While we all agreed with the sentiment behind Ted's proposal, however it appears to be a flash idea, taken from a different set of circumstances.

1) We contacted 10 other associations The Korean Veterans, The Scots Guards D. Day Veterans Royal Artillery Association, 15/19 Hussars Kings own Yorkshire Infantry, RAFA, Kings Own Scottish Borders, Queens Royal Hussars, Green Howards, and had a chat with many more. Some of these are what I term alive i.e. the mother organisation is still in existence, therefore getting a trickle of new members, others dormant i.e. campaign orientated membership finite and getting older. The general reaction was; who is prepared to take on a venture of this nature, it will be an administration nightmare and costly. We already have the RBL, Confederation of British Service and Ex- service organisation, Veterans UK and many more. Some thought it disrespectful to Her Majesty's Ministers to suggest that they can be cajoled, Also there would be conflicted with other association's

Conclusion: Too costly, administrate nightmare, adding yet another organisation to the hundreds already existing and would most probably become a dodo in very short time

2) Veterans; Again very little interest, most will meet up with their mates, others meet friends on a regularly in the local RBL/United Service clubs their Service/Regimental Association, others have joint other association i.e. There are two members of the Burma Star association who have joint Tyneside Branch of the NMBVA

Conclusion; all are happy that both they, and their dependants area very well cared for and do not need another organisation to take care of their welfare

- 3) Arboretum; Mr Ted Pemberton was very concerned that memorials who no longer have a sponsor, would be neglected and in due course be destroyed. I have a written undertaking from the Director of the Arboretum, that the trustees will maintain all memorials that no longer have a sponsor, citing the Dunkirk Veterans memorial. The letter also goes on to ensure the NEC, while they are encouraging sponsors who still have the old brick plinth type memorial to rebuild them with natural materials they will not knock down those who no longer have a sponsor.
- 4) **British Forces Pension Scheme**. Pensions have evolved over time, today's service man/woman start to accrue their pension the day they join. While those who do not complete 22yrs do not receive their pension until they are 6o, however it is inflation proof (Compounded), and there are a lot of add-ons that the individual can take on. It is rather complicated; the

scheme depends on the date of joining. Nevertheless today's pension scheme is very good and more than comparable with the US Army. It is unrealistic to pay pensions in retrospect and financially impossible. When we signed up, we signed a contract, and in my view the service man/woman are one of the best looked after groups in the country PELEASE SEE ARMED FORCES PENSION SCHEME ON THE WEB

Conclusion; The above answers both questions concern Ted While we believe the sentiment behind the proposal was great, there are organisations already in excitants, and therefore not necessary
